The O'Neal Report by Michael O'Neal - Winter 2022 Newsletter

Ouch! - As you know, the market has been brutal this year. The only upside is that our StanCERA portfolio is structured so that we don't have to sell assets in a down market, so our losses are minimized. It is still painful in the short term, but our fund has performed well over the last ten years. As of September 30, 2022, our fund had earned a 6.8% return. That included this year's market downturn of nearly 20%. The thing that is hurting most of us as retirees is inflation. It eats away our purchasing power and we are limited to a 3% COLA, so any way you slice it, we are feeling the pain. The sooner inflation gets under control, the better for everyone.

The StanCERA Pension Administration System (PAS) project officially ended September 30, on time and under budget. This includes the StanCERA web portal. StanCERA is putting together a focus group to test and provide feedback regarding the registration process and functionality of the website. When testing is completed, StanCERA members will be sent information on how to register to use the site. You will be able to use the site to change basic information such as your address or your tax withholding, etc. The rollout will be done in phases so as not to overwhelm the system staff.

Last, the StanCERA chief executive officer recruitment to replace our retiring CEO Rick Santos is still underway. By the time you receive this newsletter, we may have found our person. Rick is scheduled to leave at the end of December; however, he has agreed to stay on for a month or two depending on the timing and the experience of the new person.

Your board continues to work to keep our funds safe and our office functioning at a professional level. Kudos to the staff for completing the PAS and for staying safe through the COVID pandemic while getting the job done.

Do You Need a New Best Friend? by Carolyn O'Neal

Have you considered adopting a pet? How about a shelter dog?

With shelters overflowing, this is a great time to consider bringing a four-legged companion into your home. Not only will you gain a loving companion, you may find that you feel better and healthier. Research shows that there are multiple health benefits to pet adoption. For example, just petting a dog has been shown to reduce the stress hormone cortisol, and caring for a dog releases oxytocin, the bonding hormone that calms us and increases our trust in others. Dog owners are generally healthier than non-dog owners: according to a study published in the Journal of Psychosocial Nursing and Mental Health Services, older people who walk their dogs are more physically fit than the elderly who walk with other people. Many dog owners see a decrease in bloodpressure, triglycerides and cholesterol levels, making them less at risk for heart-disease. The American Heart Association found that dog owners are 54% more likely to get the recommended amount of exercise than their non-dog owning counterparts. You may also develop a stronger immune system from being exposed to pet fur and dander (plus a little added exercise from the vacuuming). And it's no secret that pets can contribute to happiness. Studies show that dogs reduce stress, anxiety, and depression; ease loneliness; encourage exercise and improve your overall health.

If you elect to adopt (rescue) from a shelter, expect to pay a fee. Shelters rely on fees as well as donations in order to provide the animals that come into their hands with veterinary care, dental care and neutering. You might consider adopting a senior pet. Senior dogs, while they still need walks and exercise, are more likely to be content to relax and snuggle on the couch with you. They are usually house trained and are less likely to chew up your shoes than a puppy. Here are some resources if you're interested in adopting or fostering a pet!

ASTRO Foundation (209-604-2649) places senior kitties with seniors for no adoption fee.

Muttville <u>https://muttville.org/how_to_adopt</u> in the Bay Area places senior pets free.

Elder Paws <u>https://elderpawsfoundation.org</u> rescues senior dogs and places them in homes to be fostered or adopted. (RESCO member Jackie Hubbard fosters older dogs for this fine organization).


Pupz n Palz (209-480-8662) rescues dogs and cats and places them in foster care or for adoption.

Stanislaus County Animal Services (209-558-7387) always has many, many dogs and cats just waiting to become your new best friend.

Of course, a pet is a big responsibility and there is expense involved: Pet food, vet checks, etc. But picture yourself strolling around your neighborhood in the fresh air greeting fellow dog walkers. Or perhaps curled up on the sofa with your pet peacefully snoozing beside you. It could be the best investment you've made yet. And after all, this could be your new best friend. And that's priceless.

Note from Rhonda Biesemeier: I travel frequently and use a house sitter to stay with my pets while I'm away. Sometimes it's very difficult to find someone reliable. I have been very fortunate to have friends recommend young adults who help me out. However, the above-mentioned Jackie Hubbard told me about a company called **Rover** <u>www.rover.com</u> where you can hire house sitters to either take your pet to their home, or who will come to your home to pet/house sit. I thought this was a good option in case my usual house sitters are unavailable. They also offer other services that might be helpful to seniors, such as dog walking & doggy day care. As a disclaimer, I have not used **Rover** and this is <u>NOTA RECOMMENDATION</u>, just a suggestion.

Local Service Organizations Help Our Community

Those of you who attend our Quarterly Luncheon Meetings know that we collect a voluntary, or free-will, donation each quarter to send to some of our local charitable organizations. This quarter, I'd like to highlight why we chose them, and what services they offer in our Stanislaus County communities.

When we were deciding which organizations we wanted to support, it was important to the RESCO Board that the groups we chose had no specific eligibility requirements for community members to receive their services. Since we have four Luncheon Meetings per year, each group receives a donation once a year from RESCO on a rotating basis. These organizations are very appreciative of our help, and these are all extremely necessary services to our Stanislaus County neighbors!

United Samaritans Foundation's mission is to "Feed the Hungry" and began in 1994 as a volunteer effort. They now have two warehouses, a central kitchen, and administrative offices. Some of their accomplishments include:

- Partnering with MJC West, East & CSUS to distribute Emergency Food Boxes to students
- Feeding the hungry through their Daily Bread Mobile Lunch Program. The five mobile lunch trucks make 54 stops in eleven communities in Stanislaus County.
- Partnering with Legacy Health Endowment to offer financial subsidies for people struggling to pay for medications
- Hosting monthly medical clinics in Turlock through Castle Family Health & UC San Francisco

The Food Initiative of Greater Stanislaus - (formerly Interfaith Ministries) Their motto is: "Many faiths; one purpose - restoring dignity, health & hope". Interfaith Ministries began over 40 years ago by people of diverse backgrounds & faiths. Some of their many services include:

- Providing a Healthy Food Pantry & free Mobile Farmers Markets
- Making food deliveries to homebound seniors and disabled individuals
- Offering haircuts by licensed volunteers, showers at their partner's Cleansing Hope Shower Shuttle, followed by shopping at the Interfaith Clothes Closet where clients can receive up to 20 items of clothing per month

The Salvation Army Modesto Corps. - While the Salvation Army is based on Christianity, their goal is to care for the lost, feed the hungry and comfort the hurting and they serve without discrimination. The Salvation Army was founded in 1878. Some of their services include:

- Providing overnight and emergency shelters to transitional living center
- Assisting clients with paying their utility, rent and other vital bills
- Offering educational resources, career coaching and job placement opportunities
- Providing meals and distributing food to those facing food insecurity
- Running a California Department of Education state funded pre-school/day care center
- Helping with alcohol & drug rehabilitation for adults
- Operating a low-income apartment complex for seniors in Turlock
- Providing emergency response and disaster recovery services

Modesto Gospel Mission - The Mission was created in 1948 to feed the hungry and homeless men of

Modesto. Their vision is to provide a place for refuge, recovery, and restoration. Some of their services include:

- Offering programs designed to help individuals escape homelessness
- Helping men and women with recovery from alcohol and drug abuse
- Offering case management services, meals, life skills classes, and more
- Running a program for children and teens which includes tutoring, reading assistance, and recreation
- Providing overnight shelter for men & women with a safe place to sleep, showers, & meals
- Offering a free medical clinic staffed by volunteer medical professionals

The 2023 Open Enrollment period for the RESCO benefit plans has come to a close. For those who attended the annual RESCO Health Fair at the Elks Lodge, we hope you had a good time and that we were able to answer all your questions. For those unable to attend, we hope our Benefits Guide, website videos, and our phone staff were able to answer all your questions and you were able to enroll in the best plans for you.

For those who newly enrolled in coverages, you will be receiving confirmation of enrollment directly from the insurance carriers. ID cards are usually mailed out 1-2 weeks before coverage is set to start. Therefore, expect to receive your ID cards and Certificates of Insurance toward the end of December.

Members who did not make any changes to their dental and vision plans will NOT receive new ID cards.

If for any reason you have not submitted your Health Election Form, but were interested in enrolling or changing current coverages, please call us as soon as possible at (800) 511-9065 and we may be able to assist.

During the year, Pacific Group Agencies representatives are available to assist you if you are having issues with your insurance coverage and cannot get a resolution from the insurance company. If you have already spoken with the insurance company and been unable to resolve your issue, please contact us at (800) 511-9065, Monday-Thursday 9 AM - 4 PM and Friday 9 AM - 3 PM PST.

If you have a question about a claim, need a new ID card, have questions about your benefits, need a list of in-network providers in your area, or need to change HMO doctors, please contact the Member Services Department of the respective insurance company.
