President's Message by Kathy Young

This year has gone by quickly. It's hard to believe that the holidays are just around the corner. SCARE board members have continued to be active in attending Board of Supervisors (BOS) meetings, talking with BOS members and keeping the COLA issue active. We ask that you continue letting the BOS know how you feel about not having COLAs for almost 18 years. SCERA (Sonoma County Employees Retirement Association) gave a State of the Pension System Report to the BOS on October 21, and the BOS reviewed their legislative agenda on October 28. We will be talking about both at our November 18 Membership Meeting.

Next steps for SCARE include establishing a PAC to support elected leaders who support county retirees in getting COLAs and maintaining medical benefits. It is important to emphasize that these issues influence existing staffing by impacting recruitment and retention issues. Retirees have spent many long hours helping Sonoma County residents. Phyris has been working with SCERA to change the wording in their written and electronic materials to reflect that there isn't a specific COLA schedule.

At our next SCARE Membership Meeting Julie Wyne, CEO of SCERA, will be our speaker. This promises to be an information packed meeting. Other important topics include voting on SCARE Board Members for 2026/2027. Continuing board members include Chris Bauer, Phyris Tobler, Paul Carroll and Lou Maricle. A prospective board member, Sherry Parr, is looking forward to joining the board. We still have one opening remaining so if you might be interested or have questions, give me a call. We encourage all of you to talk to county retirees and make sure they are SCARE members. What we do benefits all county retirees. November 18th Membership Meeting Speaker

Julie Wyne, the CEO of SCERA, will give us an update on status of the pension fund and on actions being taken by SCERA and the County to provide a COLA. These presentations are always very informative. Feel free to ask questions as she is prepared for that. Our members usually have a lot of questions.

Julie provided a State of the Pension Report for 2025 to the Board of Supervisors on October 21st. Several SCARE members spoke about the need for a COLA but it would have been more impressive if we had more members present. We are hoping we can get more members there for the 10/28 BOS meeting on setting legislative priorities for the County. It is really important to have the BOS give legislation re COLAs a very high priority.

Emergency Prep Help (EPH)

Seniors are the fastest growing demographic in Sonoma County and in California. They are also the most vulnerable in emergencies and disasters for a variety of reasons. EPH provides workshops for seniors that provide information and strategies on what to do to prepare for an emergency and what to do in an emergency. As part of the 2 session workshop, you get a go-bag with supplies and a great deal of information. They have workshops in various parts of the county. Information on the various workshops is available online at https://www.emergencyprephelp.org/events. You can go online to check out location and date for upcoming workshops. They are in different cities in the county. There are 2 sessions 2-3 weeks apart, each one being 2 hours. Anyone 55 and older can attend free.

Medical Equipment Recycling Program (MERP)

MERP is expanding to two days per week— Monday and Wednesday from 11 am to 1 pm. They are located at 3650 Standish Ave, Santa Rosa (in parking lot of the Child Parent Institute). This is run entirely by volunteers. They take donations of any gently used or new medical equipment and make it available **free** to anyone who needs it. Items that they can use/make available are wheelchairs, walkers, commodes, canes, adult diapers/briefs, first aid supplies, safety equipment. MERP has now added a site in Cloverdale. It is only open on Fridays from 11 am to 3 pm. It is located at 247 Treadway Dr, Cloverdale. Phone number for both is 707 353-3416.

There is a similar service in Petaluma called Homecare Equipment-Supplies located at 3820 Bodega Ave. It is open on Thursdays from 11am to 3 pm. Phone number 707 364-0305.

Ongoing Effort to Get COLAs and Changes in the Settlement Agreement re County Contribution for Health Insurance

We are in a holding pattern after the presentation to the Board of Supervisors. They were very receptive to need for COLAs and referred it to County Council to look at ways legislation could allow them more flexibility in giving COLAs but the budget for 2025-26 has been approved without a COLA in it which means no COLA next year. **There is a BOS meeting on October 28th where the Board will set its legislative priorities**. We will be attending as well as sending out email to members asking them to attend. We hope to pack the room to show the BOS how important this is to retirees. We will let you know the result at the November Membership Meeting.

We still encourage you to write to your Board member, even if you have in the past. Following are some of the points we made to the Board of Supervisor members when we met with them. You may want to include some of them in your letters although if the lack of a COLA has had a major negative affect on you, be sure to focus on that and explain how it has impacted you.

- Sonoma County's Ad Hoc COLA which promises to keep retirees at 80% of purchasing power is not working. Sonoma County retirees have not been granted a cost of living increase since 2008, and those who retired after 2003, have never gotten a COLA. Other public agencies in California have automatic COLAs which means they get a 2 or 3% COLA every year. County said they would give COLAs to keep retirees at 80% of purchasing power.
- ♦ About half of retirees get \$2,500 or less—and sometimes much less. There are people who retired in the 1970s, 1980s and 1990s when salaries were much lower compared to today's, so they have very low pensions. There are 765 retirees who retired before April 1999 who have lost 78% of their Purchasing Power as of March 2025, and they started out with very low pensions. - ♦ 32% of Safety retirements and 5% of General retirement are based on duty disabilities. They are younger, often with families and high health insurance costs, and they average \$1,000/month less than regular service retirements. They are many years away from being Medicare eligible.
- Having no COLA affects the County's ability to hire and retain employees.
- Sonoma County has a very high cost of living, but if retirees move, they often have very high health insurance costs unless they are Medicare eligible.
- As retirees age, their costs go up as their health deteriorates and they need to hire people to assist them with daily needs. If they need to go into assisted living, it becomes very expensive.
- ◆ The Board of Supervisors has shown that they care about older people as they adopted a comprehensive Master Plan for Aging, which ensure that the increasingly aging population can age with dignity and independence. But they seem to have forgotten about their own retirees.

In addition to our discussion with the BOS about COLAs, we are also asking them to modify the SCARE settlement agreement and increase their contribution for those impacted (those who retired before June 30, 2016) as it is due to decrease to \$200/month in July 2026 for those folks and also to eliminate the clause that the contribution will be stopped in 2041. Possible upcoming federal insurance changes could further impact retirees

Fact Checking Social Media Posts

There have been a lot of misleading posts on social media for a long time. But with AI, they are getting much more sophisticated. For instance, they now show photos of people saying and doing things that are not real but it looks like the person and sounds like them. Sometimes there are little clues that it is a fraud but not always. These then get circulated as if they are the truth.

Snopes.com is a website that tries to check these out and debunk the ones that are not true and it also shows ones that are true. This will not help if someone is out to scam you in particular but it will allow you to check things that are circulating on social media.

While there have been many warnings about scams, we have to be even more careful now as there are so many ways to mislead us.

For other major stories, circulated on the news or on social media, you can go to **FactCheck.org**. They cover stories that are happening on a national level and often go into a lot of detail.
